Each day TMC's leadership and employees work to carry out the hospital's mission of providing quality care, delivering innovative services and exceeding expectations.




## **Community Served – Grayson County**

In 2021, Grayson County, TX has an estimated population of 139,336. Between 2020 and 2021 the population of Grayson County, TX grew from 135,543 to 139,336, a 2.8% increase.


The ethnic composition of the population of Grayson County, TX is composed of 87.3% White Alone residents (121,640), 15% Hispanic or Latino residents (20, 900), 6.2% Black or African American Alone residents (8,638), 2.9% Two or More Races residents (4,040), 1.5% Asian Alone residents (2,090), 1.9% American Indian & Alaska Native Alone residents (2,647), and 0.1% Native Hawaiian & Other Pacific Islander Alone residents (139).

## Grayson County Health Community map




### **Health – Grayson County**

84.1% of the population of Grayson County, TX has health coverage, with 44.4% on employee plans, 12.4% on Medicaid, 13.1% on Medicare, 12.1% on non-group plans, and 2.15% on military or VA plans.




Primary care physicians in Grayson County, TX see 2,161 patients per year on average, which represents a 2.17% increase from the previous year (2,115 patients). Compare this to dentists who see 1,548 patients per year, and mental health providers who see 778 patients per year.





# **Heart Disease – Grayson County**

According to Centers for Medicare & Medicaid Services, 34.37% of Medicare beneficiaries in Grayson County suffered from ischemic heart disease in 2018. This is above both the state and national averages of 28.99% and 26.81% respectively.





The Centers for Disease Control and Prevention (CDC) reports that the total cardiovascular disease death rate per 100,000 people aged 35 and older in Grayson Country as being 501.3 between 2018-2020. This is higher than the state rate of 432.6 and the national rate of 422.4.







The CDC reports the average estimated total cardiovascular disease hospitalization rate per 1,000 Medicare beneficiaries, 65+ in Grayson County between 2017-2019 as being 81.5. This is higher than the state rate of 61.1 and the national rate of 60.7.

















## **Acute Myocardial Infarction – Grayson County**


The CDC reports that the Acute Myocardial Infarction (AMI) death rate per 100,000 people aged 35+ in Grayson Country as being 51.5 between 2018-2020. This is below the state rate of 64.1 and above the national rate of 51.2.






The CDC reports the AMI hospitalization rate per 1,000 Medicare beneficiaries, 65+ in Grayson County between 2017-2019 as being 9.6. This is above the state rate of 7.4 and the national rate of 7.3.







## **Hypertension – Grayson County**

According to Centers for Medicare & Medicaid Services, 62.86% of Medicare Beneficiaries in Grayson County had a diagnosis of hypertension in 2018. This is above both the state and national averages of 59.87% and 57.20% respectively.





The CDC reports that the hypertension death rate per 100,000 people aged 35+ in Grayson Country as being 317.4 between 2018-2020. This is below the state rate of 337.1 and the above the national rate of 268.4.








# **Hyperlipidemia – Grayson County**

According to Centers for Medicare & Medicaid Services, 52.31.97% of Medicare Beneficiaries in Grayson County had a diagnosis of hyperlipidemia in 2018. This is above both the state and national averages of 49.47% and 47.66% respectively.




# **Diabetes – Grayson County**

According to Centers for Medicare & Medicaid Services, 28.33% of Medicare Beneficiaries in Grayson County had a diagnosis of diabetes in 2018. This is below the state average of 28.79% and above the national average of 26.95%.




The CDC reported that the age-adjusted percentage of 20+ year olds who have a diagnosis of diabetes in Grayson County as being 9.1% in 2017.




# **Obesity – Grayson County**
